CHARACTERISTICS

Multi Silver Light is a universally adhesive filling and fine putty

- Extremely easy to work
- Layer to any thickness
- Adhesion to galvanised steel sheeting
- Adhesion to aluminium and steel surfaces
- Superlight sanding properties

APPLICATION

For filling in deep uneven areas and dents on motor vehicle bodywork in the area of cars, lorries, buses and railway vehicles.

PRODUCT DATA

MATERIAL DATA:

- Delivery viscosity at 20°C: as a paste

- **VOC content:** 2004/42/EG-II;2b(250) < 250g/l

- Shade: Silver

HANDLING

BASE:

The base must be clean, dry and grease-free. Good adhesion is achieved on all roughly sanded bases such as e.g. woods, metals (also galvanised) and polyester laminates (not on thermoplastic acrylic systems).



DOSING:

Addition of 2-3 % by weight hardener paste.

Overdosing of the hardener paste is to be avoided. Bleeding-through and colour changes in the finishing coat might be the result.

POT LIFE:

At +20°C room temperature, 4-5 minutes.

REACTION TEMPERATURE:

At least +5°C.

APPLICATION:

Spread on with a spatula

DRYING TIME:

Air drying at + 20°C room temperature, 20 - 30 minutes.

SANDING CHARACTERISTICS:

Following drying times given.

As filling putty

First sanding - dry with P80 - P120 Re-sanding - dry with P120 - 240

As fine putty

First sanding - dry with P120 - P180 Re-sanding - dry with P180 - P240

REWORKING:

The Multi Silver Light putty can be worked over with the following CS products:

- Elastic weiss or Elastic beige and Spray



STORAGE:

Ca. 6 - 8 months at 18 - 20° C in closed original container
